Secchi disc readings; 6-14-19 7'; 6-21-19 7'; 6-28-19 6.5'; 7-2-19 6'; 7-9-19 5.5'; 7-12-19 5.5'. It was the general sentiment of the board in discussion that conditions currently warranted reconsideration of expanded algal treatment on Long Lake.


New Business

2. The composite lake survey will not likely occur until after any algal treatments have been completed.
3. The terms for the Long and Palmer Lake property owner representatives on the board will expire at the end of the year. There will be an announcement place in the Sturgis Journal about the openings on the board. Appointment will occur at the 9-28-19 for the subsequent 4-year term.
4. RFPs will be solicited for an aquatic vegetation treatment applicator prior to next year's assessment renewal.

5. Motion to begin expanded algal treatment on Long Lake, with monitoring, as described in the original submission, as soon as feasible by the applicator.
